SEOUL FOREIGN SCHOOL VISITOR CODE OF CONDUCT - GENERAL VISITORS

As a Visitor to Seoul Foreign School(SFS) I am aware that:

- The School has CCTVs in operations around the campus.

I will not:

- Enter classrooms without permission from a member of SFS.
- Take any photographs of students, without explicit permission from the relevant SFS staff.
- Be alone or isolated (out of earshot or out of sight) with any student at any time.
- Touch or invade the personal space of any child nor approach a child in order to chastise them because of alleged actions of the child.
- Use student-only restrooms.
- Be under the influence of alcohol or illegal drugs at any time while visiting SFS.
- Engage in smoking cigarettes or vaping. Seoul Foreign School is a smoke-free school.
- Reveal personal information regarding sex, drugs or alcohol to a student.
- Accept gifts from or give gifts to students without the knowledge of their guardians.
- Exchange contact details with a student or engage in private communications with students. Text
 messaging, personal email, Facebook, Twitter or other forms of electronic or social media
 communication are not allowed.
- Meet students on campus outside of school hours, unless on official school business, after consultation with the Principal of the student, and with written parental consent.
- Discuss any information about a child or employee beyond the reason for the visit.
- Damage or destroy any school property.
